Summary of the Convictions:

- 1- Selçuk Kozağaçlı
- a) Being a membership of a terrorist organization (Article 314/2 of Turkish Penal Code): 8 years
- b) The penalty was increased by half on the grounds that it was a terrorist offense: 12 years.
- c) It was decided not to apply the reduction provisions listed in the law, stating that he did not show remorse.
- d) Making propaganda (Anti Terror Law, Article 7/2): Additional 1 year.
- e) In total: 13 years
- 2- Barkın Timtik
- a) Being a membership of a terrorist organization (Article 314/2 of Turkish Penal Code): 8 years
- b) The penalty was increased by half on the grounds that it was a terrorist offense: 12 years.
- c) It was decided not to apply the reduction provisions listed in the law, stating that he did not show remorse.
- d) Making propaganda by 6 different criminal acts (Anti Terror Law, Article 7/2): Additional 1 year x 6 acts = 6 years.
- e) Making propaganda (from another case that was merged with this one) (Anti Terror Law, Article 7/2), additional 1 year.
- f) Resisting to prevent the execution of a duty, Turkish Penal Code 265/1: additional 1 year
- g) Participation in an illegal demonstration (Law No:2911, Article 32/1), 6 months
- h) In total: 20 years 6 months
- 3- Oya Aslan:
- a) Being a membership of a terrorist organization (Article 314/2 of Turkish Penal Code): 7 years
- b) The penalty was increased by half on the grounds that it was a terrorist offense: 10 years 6 months
- c) It was decided not to apply the reduction provisions listed in the law, stating that he did not show remorse.
- d) Making propaganda by 6 different criminal acts (Anti Terror Law, Article 7/2): Additional 1 year x 6 acts = 6 years.
- e) In total: 16 years 6 months
- 4- Taylan Tanay:
- a) Being a membership of a terrorist organization (Article 314/2 of Turkish Penal Code): 5 years
- b) The penalty was increased by half on the grounds that it was a terrorist offense: 7 years 6 months
- c) and a reduction was applied based on his demeanor at the trial: So: 6 years 3 months
- d) Making propaganda by 5 different criminal acts (Anti Terror Law, Article 7/2): Additional 1 year, but a reduction was applied based on his demeanor at the trial so 10 months \times 5 acts = 50 months, 4 years 2 months
- e) Considering the status of the defendant, his lack of criminal record, etc., it was decided to defer the announcement of the propaganda verdict and the colleague was subjected to probation for 5 years.
- f) Resisting to prevent the execution of a duty, Turkish Penal Code 265/1: additional 1 year, with the reduction 10 months (and again defer the announcement of the sentence for this crime)
- g) In total: 11 years 3 months
- 5-: Nazan Betül Vangölü Kozağaçlı
- a) Being a membership of a terrorist organization (Article 314/2 of Turkish Penal Code): 5 years
- b) The penalty was increased by half on the grounds that it was a terrorist offense: 7 years 6 months
- c) and a reduction was applied based on his demeanor at the trial: So: 6 years 3 months
- d) Making propaganda by 2 different criminal acts (Anti Terror Law, Article 7/2): Additional 1 year, but a reduction was applied based on his demeanor at the trial so 10 months x 2 acts = 20 months, 1 years 8 months

- e) Considering the status of the defendant, his lack of criminal record, etc., it was decided to defer the announcement of the propaganda verdict and the colleague was subjected to probation for 5 years.

- c) and a reduction was applied based on his demeanor at the trial: So: 6 years 3 months
- d) In total: 6 years 3 months
- 8- Naciye Demir (remember that she was already convicted for the membership in the case of 2017 so this court could not sentence her with the same crime since she was already convicted)
- a) Making propaganda (Anti Terror Law, Article 7/2): 1 year for 5 different acts, but a reduction was applied based on her demeanor at the trial so 10 months x 5 acts = 50 months, 4 years 2 months.
- b) Considering the status of the defendant, his lack of criminal record, etc., it was decided to defer the announcement of the propaganda verdict and the colleague was subjected to probation for 5 years.
- c) In total: 4 years 2 months
- 9- Özgür Yılmaz (remember that he was already convicted for the membership in the case of 2017 so this court could not sentence him with the same crime since she was already convicted)
- a) Making propaganda (Anti Terror Law, Article 7/2): 1 year and no reduction.
- b) In total: 1 year
- 10- Şükriye Erden (remember that she was already convicted for the membership in the case of 2017 so this court could not sentence her with the same crime since she was already convicted)
- a) Making propaganda (Anti Terror Law, Article 7/2): 1 year for 4 different acts, but a reduction was applied based on her demeanor at the trial so 10 months x 4 acts = 40 months, 3 years 4 months.
- b) Considering the status of the defendant, his lack of criminal record, etc., it was decided to defer the announcement of the propaganda verdict and the colleague was subjected to probation for 5 years.
- c) In total: 3 years 4 months
- 11- Ebru Timtik: The case against him was dropped.
- 12- Günay Dağ and Zekir Rüzgar: Their cases were separated since they were never brought to the court.
